## **7 EV Charging Points Update**

The Committee at its meeting on 17 July 2023, Minute 28 – 2023/24 made recommendations agreed at the Council meeting held on 7 August. Central Bedfordshire Council has welcomed the Town Councils' decision to go ahead with a programme of installing EV charging points in Sandy. Additional information has since come to light and that was not reported at the Council meeting.

Option 1, which was agreed at the last Town Council meeting in August will now also include rapid charging points. It is understood that rapid charging points were expected later in the second phase and that this element has simply been brought forward. To confirm the following is what will be installed:

#### **OPTION 1**

3 x 50kW rapid charge points over 6 bays (wholly BP Pulse funded)

4 x 7kW standard charge points over 8 bays (50% grant funding/50% BP Pulse, with some revenue share to Sandy Town Council)

At this stage, the Committee is asked to agree to the additional arrangement because the Town Council has promised CBC that the TC will officially sign up to the arrangement. Failure to do so could mean the Town Council misses out on all the negotiated arrangements so far.

#### **RECOMMENDED:**

- 1)That the amended Option 1 be approved and the letter to confirm the Council's agreement be submitted to CBC as soon as possible.
- 2)That further to the Councils' agreement to work with CBC the implications for the management of the Carpark be referred to the Carpark Working Group.

## 8 Provision of Clothing bank at the Town Council Car Park

The Council has been approached by the provider of a clothing bank (see attached information). The money raised from the ASTCO clothing bank would be returned to the Council for it to allocate to charitable purposes. There are two clothing banks already in situ in the car park that were not directly approved by the Council. It was resolved at **54-2018/19** Minute refers that they could remain in place until the Council made alternative arrangements.

#### It is **RECOMMENDED:**

- (1) that ASTCO be allocated the site at the Carpark and the funding raised be directed to the Mayors Charity account so the charities selected by Mayors will benefit from the funding in the future
- (2) that the Deputy Clerk make arrange for the existing textile and shoe banks to be removed.

#### 9 Tree Surveys

Before Covid, the Council had an arrangement to receive regular reports from Steve Dear Tree Services. This service ceased in 2020. It is very important to keep this service in place to ensure the Council's trees are safe and that any works are identified and undertaken accordingly. Members are asked to consider quote for works to undertake tree surveys as follows;

Beeston Green - £350 exc VAT

Willow Island - £350 exc VAT

for tree surveys.

Bedford Road Recreation Ground - £350 exc VAT

Sandy Cemetery - £350 exc VAT

Closed Churchyard St Swithun's Church - £350 exc VAT All trees over 150 mm diameter at 1.5 m marked with a numerical tag to aid identification. Species, height, stem diameter, crown spread listed for each tree. General condition and structural condition listed for each tree. Recommendations for works if required will be prepared and a timescale given. **RECOMMENDED** that the Committee accepts the quote for a total of £1,750 excluding VAT from Steve Dear Tree Services

#### **Sandy Town Council**

Title: Robotic Line Marking Service

Contact Officer: Deputy Town Clerk

#### **Purpose of the Report**

1.0 To consider a report on the possible use of a robotic line system that would mark the football pitches to a premiership football pitch standard.

- 1.1 When the line marking service is purchased, the company will first visit the site(s) to understand the location and size of the pitch or sports field that are to be outlined. There is no limit to how many pitches that can be outlined as part of a single project, with the efficiency of the robotic line marking process meaning that a week's worth of manual line marking can be carried out in a single afternoon.
- 1.2 Once the plan is in place the pitches will be marked on the tablet tool which connects to the robot, before switching the robot on and putting it into its start position. The process is automatic as the robot follows the markers laid out on the tablet screen. Records will be created and stored that can be tuned into the robot at a future date to enable enhanced efficiency for the next season, alleviating the need for the marking process to be repeated year after year, and instead letting the robot tune into its now automated setting.

#### Recommendation

2.0 That the Committee supports the purchase of the system for the sum of £500.

### **Background**

- 3.0 The technology of robotics allows the Town Council to mark out pitches accurately and can be in place for the remainder of the season, allowing grounds staff to carry out other tasks.
- 3.1 The cost would be £500. Once mapping is stored in the robot it can be carried out season after season with no reprogramming required as it is locked into an automated setting.

#### **Financial Implications**

5.0 The cost of £500 is considered a cost-effective use of resources and allows ground staff to prioritise other works. Also a 1-2 day LANTRA course for 2-3 people would be well over £500.

#### **Legal Powers**

6.0 The actions undertaken are covered by the Localism Act 2011, s.1 the General Power of Competence, for which Sandy Town Council is eligible and is a power of first resort, allowing the Council to do anything an individual can do.

Following my telephone this morning I am now emailing the following information as you requested regarding raising funds for the council/community by using a clothing bank.

The Funds raised go back to you to use in any way that you wish.

I am contacting you as we are working alongside town councils in the area and helping them to raise funds by using one of our clothing banks. I understand that you have recycling banks at High Street Car Park and at the Welcome Store and wanted to explain that we pay for what is collected and wanted to offer you the opportunity to raise funds for the council/community by having a clothing bank at each location which is completely free and the funds raised go back to you to use in any way that you wish.

We are local to you as we are in Sandy, and it would be great to support you in raising funds. All we ask is for a small space to place the clothing bank where visitors to the car park can donate their unwanted shoes, clothing accessories which we collect on a regular basis and pay you for what is collected at the beginning of each month.

Please find below some more information on us and how it works! It's a fantastic way to raise funds all year round with a regular monthly income stream (3) Any questions at all please let me know!

#### **ABOUT US:**

We provide a service across the East of England helping communities fundraise by recycling clothing. How we do this is we can place a clothing bank on your premises – our outdoor banks are usually placed in a car park or surrounding area or anywhere you think would be a great location for visitors (any surface, grass, gravel etc) The clothing bank and whole scheme is completely free of charge at no cost to you whatsoever, which allows the general public and your visitors to donate their unwanted clothing and shoes. Anything collected from the clothing bank, we will then pay you for.

This is a fantastic fundraising opportunity for you to raise more funds to support your facilities. The ASTCO driver will empty the clothing bank at least once a week or as often as needed. With all weights collected recorded on your account then payment is made once a month the following month to you. We pay 30p a kilo, which is £300 a tonne, there is no minimum amount to reach in order to receive payment (such as £30, £40 etc) we pay each month regardless to you, as we know how vital fundraising can be for communities.

The clothing bank dimensions of the outdoor bank are: Height: 6'3ft Width: 4ft Depth: 3'6ft

We work with other Parish councils, village halls, churches and community projects around the East of England and have been raising money for many years for charities. To name a few, we currently work with The Firefighters Charity (you will see our yellow banks outside fire stations) Scotter Village Hall, Swinderby Parish Council, Alkborough Cricket Club and lots more. We also work with North Norfolk, South Norfolk, Breckland and Broadland Council, as well as Huntingdonshire and East Cambridgeshire council too!

Everything received is re-used, recycled or repurposed so none of it goes to landfill. Feel free to check out our website for more information on this.
