## 9 Tree Issues

# (a) Tree Survey

Further to the last meeting of the Committee (Minute 39 - 2023/24 Refers) it was determined that a Tree Survey be undertaken subject to two additional quotes being sought. The Deputy Clerk now asks that the Committee agrees that the current contractor be allowed to undertake the survey because of the urgency to carry out the surveys as the trees have not been surveyed in the last 3-5 years. Also, with the continued absence of the Admin Team Leader it is anticipated there would be delays in the procurement process The Deputy Clerk believes it is in the Town Council's best interests on the grounds of safety to allow the current contractor to carry out the survey work as soon as possible this Autumn. For the next survey three quotations would be sought in accordance with Financial Regulations.

**RECOMMENDED** that the Committee accepts the quote for a total of £1,750 excluding VAT from Steve Dear Tree Services for tree surveys.

whole communities. Since it made a commitment to support the planting of 1 million trees across Central Bedfordshire 67,000 trees and more than 5km of new hedgerow have been planted. CBC continues to offer Community Tree Planting and Hedgerow Grants and will continue schemes introduced last year such as Tiny Forests and the Tree Giveaways. Town and Parish Councils are encouraged to apply. In addition to these opportunities, information is now available about a new Woodland Creation offer to all public and private landowners, schools, community groups and organisations. ## **Purpose of the Report**

1. To receive and consider a report on the SEG planting schemes that now require regular attention/ maintenance in a recognisable and acceptable way if they are to continue.

#### Recommendation

2. That the Council be asked to approve a budget line in the 2024/25 budget setting of £2,500 for the maintenance and improvements to the current SEG.

# **Background**

- 3.0 The Sandy Enhancement Group worked effectively for a number of years. Its terms of reference are set out below;
  - o To provide a forum to discuss issues of concern about the appearance of the Town.
  - To organise initiatives to physically improve the appearance of the Town in both specific locations and in general.
  - To apply for grants from outside bodies.
- Promoting competitions within the Town which enthuse and motivate its residents and enhance their section of the community.
- Advising the Town Council on the annual bedding plant programme colour scheme.
- To undertake and maintain schemes to enhance the appearance of the Town with the approval and support of the Town Council.
- To sponsor a photographic competition at the annual Horticultural Show on the theme of Present Day, Sandy.
  - To lobby the Town Council about improvements that could be made to the appearance of the Town.

• To enter regional competitions like Anglia in Bloom if the current group feels it is desirable.

The SEG disbanded some years ago. Since then, the future of the projects have not been addressed or supported by the Town Council.

3.1 A major scheme at Station Road was effectively destroyed by a vehicle recently. The railway sleepers have been collected and stored by the Town Council. Other SEG projects are the small garden entrance to Stratford Road and dry garden Bedford Road Recreation Ground as well as a project behind the Bell Public House raised bed plus the plant beds outside the Royal Mail Offices Mail Offices, High Street, Sandy.

# **Proposals/Information**

- 4.0 The SEG schemes are still part of the fabric of the town but are not all looked after in a satisfactory way. The Committee is asked to consider whether it wishes to put in a budget line for next year for their care and maintenance.
- 4.1 The Council is looking to recruit volunteers to cover services of the Council. The Officers are looking to set up 'Friends of' Groups and projects such as Incredible Edible https://www.incredibleedible.org.uk/ (probably with the assistance of Bedfordshire Rural Community Council) (BRCC).
- 4.2 The look of the town is important to the Town Council hence the creation of SEG, in the first place. The Grounds Staff do not have the capacity to take this on completely but would play a role in supporting voluntary groups or individuals.
- 4.3 Without the Council stepping in these schemes will not continue long term. The Council is looking at a way of these schemes continuing while encouraging volunteers to become involved in horticulture for their benefit and the benefit of the community.

#### **Financial Implications**

5.0 The Council is asked to support a budget line of £2,000 being put in the 2024/25 budget to support and enhance local schemes promoting the growing of vegetables, herbs, and flowers in community spaces.

6.0 The action undertaken is covered by the Localism Act 2011, s.1 the General Power of Competence, for which Sandy Town Council is eligible and is a power of first resort allowing the Council to do anything an individual can do.

Title: Playground Equipment Repairs Report

## **Purpose of the Report**

1. To receive and consider the costs for replacing play equipment and play surfaces at certain areas of the Council's playgrounds and the skatepark at Sunderland Road.

#### Recommendation

2. That the Council approves the quotations that provide the best quality product while considering value for money. The resurfacing at Fallowfield can be funded from the existing budget. The 2023/24 budget for the other play areas has only allowed a maximum £1,000 spend on recreation grounds so funding would need to come from Capital.

## **Background**

- 3.0 The Council has received the annual safety inspection reports from its consultant The Play Inspection Company.
- 3.1 The Deputy Town Clerk and the Grounds Team Leader have had meetings to address High Risk and Medium Risk issues highlighted by the consultant. Also, Maverick the creators of the Skatepark have held the snagging inspection. This has highlighted several issues including the erosion of the top of the bunds supporting the structure and a number of desire lines around the skate park that will be difficult to maintain as grassed and are likely to be slippery.

#### **Proposals/Information**

- 4.0 The consultant is concerned about the Cable Runway at Bedford Road Recreation Ground. The Council has taken the ride down until the chain links are renewed and the surface is replaced. At the moment, the safety matting is silted up and has an effect on the impact absorption. Fixings are corroded and the seat suspension does not meet the requirements of BS EN 1176 part 4. This is a very popular ride but unfortunately it cannot be used until significant remedial work is undertaken on the swing and the runway. For the maintenance of the swing the manufacturer has been contacted.
- 4.2 A number of play areas have areas that are heavily eroded and provide little impact absorption. This is due to the rubber matting not being able to provide a safe surface. The matting has been secured with plastic holding pins that are seen in the inspection as not providing a safe surface.
- 4.2 The Committees' attention is brought to the adult exercise equipment at Sunderland Road Recreation Ground by the Jenkins Pavilion. Although it is estimated the equipment is only 4-5 years old it is of poor quality and the annual safety report highlights issues caused by poor build and finish relating to rust on equipment and poor paint finish. One piece of the equipment is

marked as moderate risk because it is loose in its foundations. This is a common problem with this type of equipment.

# **Financial Implications**

5.0 The 2023/24 budget cannot meet the costs required. The funding of the works would have to come from capital or be taken forward for consideration in next year's budget. The time lapse between then and now may see costs rise further.

Title: Beeston Village Proposed Allotment Site Soil Sampling

## **Purpose of the Report**

1.0 To consider a report on the use of soil sampling at the proposed allotment site, Beeston.

- 1.1 In order to move forward on the development of the proposed allotment site the Council needs secure soil testing carried out to a satisfactory level to prove that the soils are at a safe level for allotment growing.
- 1.2 Following the receipt of the test results the Council will have evidence to show allotment growers and potentially an allotment association that the soils are safe. If the tests show there are problems with the site, the Council could consider remedial work such as topsoil replacement. Otherwise, if the soils will not support horticultural use, the Council would have to release its interest in the site.

#### Recommendation

- 2.0 That the Committee considers the two quotations received.
- 2.1 That company A be selected to carry out six soil tests at the site at an appropriate cost of £1,563 will need to come from the Rolling Capital Fund as there is no budget line attributed to this project.

## **Background**

- 3.0 The Council has approached soil testing companies that have significant experience working with principal and local councils on testing land for potential allotment sites.
- 3.1 In commissioning a company to assess contaminant levels in the soil directly in context with the proposed allotment land use, it allows the Council to demonstrate due diligence on the site prior to its use and provides re-assurance in future to show allotment users that the site has been tested and analysed, and if appropriate, confirm it is safe for allotment use.
- 3.2 It is also suggested that the Town Council works with a local expert who is very knowledgeable about the soils of Sandy and is willing to work with the Town Council on the design and potential development of the allotment site. He is supportive of the Town Councils' suggested approach in checking the soils for suitability to support a healthy allotment. He agrees with the Deputy Clerk that six tests may be sufficient rather than ten. At the appropriate time he is happy to work with the Council on allotment design and soil preparation for the allotment site being discussed at the meeting.

## **Community Tree Planting and Hedgerow Grant**

Our Tree Planting Grant remains open and will continue to help local voluntary and community organisations to deliver small scale tree and hedge planting schemes. We can provide funding (or match funding) to Town and Parish Councils, schools, community groups and organisations, to support projects that are looking to plant at least 5 trees, up to small areas of new woodland, orchards and hedgerow. # **Tiny Forests**

Tiny Forests are small areas of fast-growing, dense woodlands planted in urban areas with a mix of native tree species. They occupy no more than 200m2 (roughly the equivalent size of a tennis court) and contain approximately 600 trees. Tiny Forests can be planted in almost any shape to fit the space available and make a fantastic addition to the local landscape.

Last year the Council partnered with Tiny Forest experts, Earthwatch, to plant the first four Tiny Forests. Over 2,400 trees and shrubs were planted at local schools and a recreation ground, located in Cranfield, Leighton Buzzard, Biggleswade, and Dunstable.











To support planning of Tiny Forest planting this coming winter (the best time to plant trees) which runs from October 2023 to March 2024, the Council welcome new site suggestions from Town and Parish Councils. We would like to hear from potential sites now, with a deadline of 1<sup>st</sup> November 2023.
