## **6 Items for Information (25-2016/17)**

The Chair informed members that despite contacting the CBC Councillors regarding CBC/16/01493/PADO – 5a Market Square, Sandy, no further information regarding this was available.

The Chair read out excerpts from an article in Clerks and Councils Direct regarding GPDO from a Clerk in Kidderminster who had experienced the effects of GPDO as their local authority had granted permission for a solar park in an area of natural beauty.

The Committee felt that Town and Parish Councils should be the eyes and ears for the Local Authority and felt they have been ridden roughshod over in this case. The Committee also felt that this should be escalated to the next Town Council meeting. CBC need to take this matter seriously as it's a recipe for disaster. The Committee resolved to recommend that a press release is issued regarding this and that fellow Councils should also be informed. The Chair will talk to the Mayor to see if it can go on the next Town Council meeting or can be dealt with under this committee.

Members noted that CB/15/04456/FULL – Long Lake Meadow, High Road, Seddington, Sandy – application for change of use of land to use as a residential caravan site for the accommodation of up to 5 gypsy families, including the laying of hardstanding, would be going before CBC's Development Management Committee on Wednesday 20 July 2016. Cllr Aldis agreed that he would attend and speak on Council's behalf.

The Chair reported that issues with both Bartrams and Grange Nurseries in Beeston were still ongoing. If need be it might be worth inviting the planning officer to come in and talk about these issues.

Members discussed the changes that had been made to the Maharajah Restaurant in the Market Square. Members have concerns and the Chair would discuss these with the Clerk.

Members noted CBC's decision to refuse the application for Land West of the A1 which had been circulated previously.

Cllr Aldis asked if the comments from last week's Community plan meeting regarding the Draft Technical Assessment would be going before Town Council. The Chair believed it would be.
