### <sup>6</sup> Administration Charge

Also **RESOLVED** that other local councils be contacted to ascertain if they charged for this service and that the matter be deferred to the new Council in May.

#### 7 Rent Reviews

Members spent considerable time debating rent reviews for Biggleswade Hitchin & District Angling Association and the Reserve Forces & Cadets Association and it was **RESOLVED** to **RECOMMEND** that the Biggleswade Hitchin & District Angling Association rent should be £485.75 plus the rate of inflation in January 2015 and VAT and the Reserve Forces & Cadets Association rent be set at £190.00 + VAT for three years.

- (iii) It was **RESOLVED** that the question of responsibility for payment of a skip at Sunderland Road Recreation Ground be **RECOMMENDED** to Council and that costs for the supply of the skip be sought.
