## 6 **Street furniture, bins, and benches (34 -2022/23)**

Members received a report from the Clerk outlining several separate requests from residents for the placement of new benches, bins, and bus shelters across Sandy. The Outdoor Team Leader also provided a list of current bins and benches that needed to be replaced or repaired.

**RESOLVED** that the Outdoor Team undertake an audit of Sandy's open spaces to create a full picture of the work required to ensure provision for works is included in 2023/24 budget.

## 7 **CBC On Street Parking Consultation (35-2022/23)**

Members received a report from Cllr Sutton outlining a suggested response to the CBC On Street Parking Consultation.

Cllr Hewitt also reported that residents of the estates had raised issues adjacent to the railway station were experiencing issues with rail users leaving their cars parked in residential roads over extended periods of time while they went away on holiday. Inconsiderate parking and blocking of people's drives was a particular issue. She added that residents had complained to CBC about the problems and had been told there was little that could be done as no restrictions were in place for these areas.

## 8 **Christmas lights (36-2022/23)**

Members considered a recommendation from the Clerk to reduce the hours when the Christmas Lights burn to reduce costs in acknowledgement of the current cost of living crisis.

**RESOLVED** to reduce the time the lights burn from between 3.30pm and midnight, to 4pm and 10.30pm. In addition, Members agreed that Christmas lights should be switched off on Wednesday 4<sup>th</sup> January instead Friday 6<sup>th</sup> January, thus saving 115.5 hours of power over the period.

## 9 Mosaic Competition (37-2022/23)

Members considered a recommendation by the Clerk to delay timings for the mosaic competition following the passing of HM Queen Elizabeth II and widen the scope of the project to celebrate her whole life not just her 70-year reign.

**RESOLVED** to look contact schools in Mid-December with a letter from the Mayor priming schools for a relaunch of the competition in January with potential workshop to be held in February half term. Clerk to agree timings with Carolyn Blake.

Members considered a request from CBC to host a local event to promote its Free Tree Giveaway Scheme.

This would be reviewed once the administration team is back to full capacity. STC still remains committed to its environmental plan and tree planting scheme.

## 11 Resilient Highways Network Consultation (39 -2022/23)

Members received a report and consultation request from CBC on their Resilient Highways Network.

**RESOLVED** to respond to the consultation outlining the key routes within Sandy that were not currently included in the scheme: Bedford Road, High Street and St Neots Road.

Members received information from CBC regarding a consultation on Disabled Parking Bays at Churchill way.

**RESOLVED** to support the inclusion of a new disabled parking bay at Churchill Way. A response to Highways would note that there was already provision for one Disabled parking bay in the area and should a further application be made for this area for CBC to consider the impact this would have on the required resident parking and turning circles. Members request information on how parking bays are reviewed for continued use.

## **13 Fallowfields Paths (41-2022/23)**

Members received a verbal report from the Clerk about the condition of paths at Fallowfield recreation ground. The office had received a complaint from a resident that large cracks had appeared across the paths and were causing a potential hazard to pedestrians, cyclists, and other users. The Clerk reported the same issues could be seen across other open spaces with tarmac paths and that the issue had been caused by the intense prolonged heat we had experienced over the summer. The Clerk had spoken to the Outdoor Team leader about remedying the situations and warning signs were placed on site to take care when using the paths. It is expected that as the weather turns cooler some of the cracks will naturally start to shrink back.

**RESOLVED** that the Outdoor Team investigate methods of repair and if it is possible that these can be conducted without having to engage a contractor.
